## **2. DATA WE PROCESS AND FOR WHAT PURPOSE?**

Here is an exhaustive list for which we collect your data and how it is used.

### **2.a) General browsing**

- When you visit our internet website, we collect the data transmitted to our server by your browser.
- During your visit, only the data that are technically necessary will be collected.
- Processing is carried out in the legitimate interest of improving the site's stability and features.
- The data will not under any circumstances be transmitted or used for any other purpose.

### **2.b) Apps and softwares downloads**

- When you download one of our app or software, we collect basic information about your country and the datetime.
- Those data are anonymised and only collected for internal statistics about our apps / softwares.

### **2.c) Licenses purchases**

- Upon purchase, we collect legally necessary data to process the payment.
- We may be required to collect your name, company, address, and email to generate and send you a bill.

### **2.d) Customer service / support**

- As part of a service, we collect data that you voluntarily wish to provide us via online forms or emailing us.
- These data are processed exclusively to respond to your requests for information and their processing is based on your consent.

### **2.d) Newsletter**

- When you subscribe to our newsletter, we collect only your email to keep you informed about our news that may be of interest to you.
- You can choose to unsubscribe at any time from our mailing list by simply clicking on the unsubscribe link found at the bottom of each message.

### **2.d) Legal proceedings / requirements**

- We may use the data we collect to investigate and respond to complaints / dispute or requests from regulatory bodies, government entities or administrative investigations.

**3.e)** To avoid unauthorized access to data and generally secure the data, we apply the following safety measures: encrypted transmission, encrypted storage, an authorization concept, a data backup concept, and physical safety measures for servers. Those safety measures are constantly revised to comply with the latest technological developments.

### **4. ABOUT YOUR RIGHTS?**

**4.a)** In accordance with the Data Protection Regulations and the legal limits in force, your rights include:

- to access your data, particularly to check that they are accurate and exhaustive
- to have your data rectified or erased
- to the portability of the data
- to object to or request a restriction of the processing of your data
- to give specific instructions concerning the processing of your data following your death.

**4.b)** For the processing of your data based on consent, you also have the right to withdraw your consent at any time.

**4.c)** The withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.
